### BUILDING PERMIT FEE SCHEDULE

The Chief Building Official shall, before issuing permits for the erection of any building or structure, or for any addition to any existing building or structure, or for any alteration or repair to any existing building or structure, upon application therefore, require the payment by the applicant for such permit of fees to the amount herein below set forth and in the manner herein provided to-wit:

\$2,001 to \$25,000	\$69.25 for 1 <sup>st</sup> \$2,000 plus \$14 for each additional \$1,000 or fraction, to and including \$25,000
\$25,001 to \$50,000	\$391.25 for 1 <sup>st</sup> \$25,000 plus \$10.10 for each additional \$1,000 or fraction, to and including \$50,000
\$50,001 to \$100,000	\$643.75 for 1 <sup>st</sup> \$50,000 plus \$7 for each additional \$1,000 or fraction to and including \$100,000
\$100,001 to \$500,000	\$993.75 for 1 <sup>st</sup> \$100,000 plus \$5.60 for each additional \$1,000 or fraction to and including \$500,000
\$500,001 to \$1,000,000	\$3,233.75 for the 1 <sup>st</sup> \$500,000 plus \$4.75 for each additional \$1,000 or fraction to and including \$1,000,000
\$1,000,001 and up	\$5,608.75 for the 1 <sup>st</sup> \$1,000,000 plus \$3.15 for each additional \$1,000 or fraction

### VERIFICATION OF FOUNDATION
